The School was chartered by the University of the State of New York in May 1987, and received its permanent charter on November 14, 1997. Evangel Christian High School began in September, 2000 and as of July 2003, is permanently chartered and registered by the Regents of the University of the State of New York. The school is also fully accredited by the Middle States Association of College and Schools. We are also approved by the Immigration and Custom's Enforcement to issue I-20's and accept International Students.

As we set out to provide your children with the best education possible, we also seek your help in a number of areas. If Evangel Christian High School is going to grow under the blessings of God, it will be because of the faithful and earnest prayers of God's people. You have in your possession a monthly prayer calendar. Use it faithfully as it names the specific needs of the school. In turn, we will systematically pray for each family throughout the year.

# PHILOSOPHY OF EDUCATION

## WE BELIEVE

...that God is the source of all life and truth.

**...that the school is committed to supporting the parents in teaching and training the student "to think God's thoughts after Him," and to "bring every thought captive to the obedience of Christ."**

...that the school should maintain and strengthen our American heritage and develop in the child a love and appreciation for the rights, privileges and responsibilities guaranteed by our form of government.

...that the school should help pupils become critical thinkers - acquire factual knowledge, develop the ability to analyze facts, weigh evidence, resist destructive propaganda and form intelligent opinions - **a mastery of the necessary skills needed to apply his knowledge in service to both God and man.**

...that the school should foster attitudes that would encourage children of all races and colors to live in harmony, appreciation and understanding of one another.

...that teaching should be a process of helping, assisting, and encouraging children in a Christian atmosphere. **They are taught to respond Biblically in their actions and interactions with others. The student is taught to be obedient to the two greatest commandments as set forth by Christ, namely:**

**YOU SHALL LOVE THE LORD YOUR GOD WITH ALL YOUR HEART, AND WITH ALL YOUR SOUL, AND WITH ALL YOUR MIND....YOU SHALL LOVE YOUR NEIGHBOR AS YOURSELF. (Matthew 22:37,39 NASV)**

# BIBLICAL PHILOSOPHY

God has placed the responsibility for educating children on the parents. Educating children without the cooperation of the home is unscriptural and endangers the mental, spiritual and social well-being of those most precious to us - our children.

Proverbs declares that "the fear of the Lord is the beginning of wisdom..." Without reverence for God there is no foundation for true wisdom and thus, the whole person is not educated. Many Old Testament Scriptures shed light on training, teaching and educating our children (Deut. 6:7; 11:19; Psalm 111:10). Children should be educated where scriptural principles are in evidence -- as a lifestyle. What is taught in the Christian school must be reinforced at breakfast, at bedtime, at social activities, in athletic competition - in church and in Sunday School. Stated more precisely, Christian education should be experienced in all things, at every place and at all times.

God has called Evangel Christian School to fill a gap in our children's education. This school will serve as your partner in the Christian education of your children. Attendance at this school is a privilege and not a right. The goal of the school is not to reform, but to carefully educate children in the highest principles of character, Christian leadership, self discipline, individual responsibility, personal integrity and good citizenship.

As the faculty and staff of Evangel Christian School, we **are committed to leading each student into a vital personal relationship with Jesus Christ as Lord and Savior and to training the student to serve Christ in every area of life.** We pledge ourselves to academic and moral excellence in a Christ-centered atmosphere. It is our prayer and purpose to do all things to the honor and glory of our Lord Jesus Christ!

## STATEMENT OF FAITH

1. We believe the Old and New Testaments are the divinely inspired revelation of God and His purposes for all mankind.
2. We believe in the Triune God, revealed in the Bible and creation as Creator and Ruler of the universe. He has always existed and always will.
3. We believe Jesus Christ the eternal Son of God became man in order that God's great plan of redemption would atone for humanity and that He died and rose from the dead.
4. We believe man was created good and upright, in the image of God. By choosing to disobey God's command, man was separated from fellowship with the Creator. Suffering and death entered the world because of sin.
5. We believe man's only hope for fulfillment, satisfaction and restoration to God is the forgiveness which God has provided through the death of Jesus Christ.
6. We believe in a Triune Godhead which Christ expressed in specific terms as Father, Son and Holy Spirit.
7. We believe the Holy Spirit working within man brings salvation when he comes to God in faith. In addition, all Christians may experience an infilling of the Holy Spirit, following salvation, called the "Baptism in the Holy Spirit."
8. We believe healing is an integral part of the good news God has for the world and that God heals sickness today, as in Bible times.
9. We believe God will intervene in human affairs by the return of Jesus Christ to the earth. This will bring history to a climax and usher in a "new heaven and a new earth."

# **PARENT COOPERATION**

ECS's educational mission involves working closely with the home in the overall Christian education of students. ECS views itself as partnering with parents in the education of their children. Parents enrolling students as a condition of enrollment agree to support with and cooperate with the School in the education of their child and also agree to support the School's religious educational philosophy. This is founded upon the Biblical principle articulated in Amos 3:3, "Can two walk together, except they be agreed." Parents also agree to support the School with prayers and a positive attitude. Complaints or negative comments will be shared with the teacher, administrator or person involved, in accordance with Matthew 18 principles. Parents agree that if at any time, parents/guardians act in a manner that demonstrate a lack of support for the School or its religious educational philosophy, or otherwise reflect a lack of cooperation and commitment to the home and School working together, ECS has the right, in its sole discretion, to remove any student or to discontinue further enrollment of any student. Parents/guardians acknowledge and agree that their conduct can jeopardize the enrollment status and/or continued enrollment of their child.

## **ADMISSION POLICY**

**PREAMBLE:** Christian education involves the growth of the whole man: Therefore, it is imperative that those elements which focus on the child's education be consistent both at home and at school. For this reason it is necessary that parents are in accord with the philosophy and teaching of the school.

The following policies and standards of admission will provide consistent training and a quality education for your child.

1. The Christian school complements the Christian home; therefore, we enroll Christian families and/or parents who agree to support the Christian education offered at ECS. All parents must agree to cooperate with and support ECS in the education of their children.
2. Parents must state in writing that they have read our philosophy and statement of faith, and commit themselves to co-educate their child according to Biblical principles. Parents must also agree to support the Biblical Education taught at ECS and cooperate with the School in the educational process.
3. Parents must agree in writing that:
  - (a) parents and students will abide by the disciplinary guidelines of the School;
  - (b) parents will comply with all policies and procedures of the School, including, but not limited to, the Parent Cooperation Policy;
  - (c) parents will support the Philosophy of Education, and Biblical standards of the School;
  - (d) the school has full discretion for the grade placement of children;
  - (e) they will promptly meet all tuition and other financial obligations;
  - (d) they agree to willingly support the school in prayer and in lending practical help as required by the school
4. Parents must be interviewed by the School Representative. Students in grades 6-12 will also be interviewed.
5. Preference in enrollment will be given to our members of Evangel Church first, then to others on a first come first serve basis.
6. All families are encouraged to attend a Bible-believing church.
7. Upon confirmation by the Administration, your child will be enrolled or placed on a waiting list.

8. Acceptance or rejection of applicants will be by written notification. The Testing Fee must be paid before testing and is nonrefundable if the child is not admitted, or if the child withdraws.
9. The Administration may refuse to admit a student with severe disciplinary, psychological or learning disability problems.
10. The school does not discriminate on the basis of race, color, national origin or ethnicity in the administration of its admission policies. However, as a religious educational institution, ECS does impose religious criteria upon its students, including its conduct code, and reserves the right to discriminate on the basis of its religious standards.
11. Parents are expected to work with the teachers and staff, as a team. This includes being a Godly Christian example. Parents are expected to conduct themselves in a respectful manner, towards other students, staff members and teachers. Parents are expected to support the School and cooperate with the School in the educational process. Failure to comply in this manner could result in the removal of your child from school. The School reserves the right to remove a student from school based upon the conduct of the parent (or guardian). Parents understand their conduct can jeopardize their child's enrollment status.
12. Students who do not desire to attend Evangel Christian School will not be allowed to attend or remain in school.

## **APPLICATION AND REGISTRATION PROCEDURES**

### **PREK – 8<sup>th</sup> GRADE APPLICATION AND REGISTRATION PROCEDURES**

#### **USING TADS PARENTS MUST:**

1. The Student Application must be completed in every aspect and forwarded to the school office along with the application fee and testing fee:
2. The following must be provided for each student that applies:
  - (a) A completed Student Application form and Annual Parent Questionnaire
  - (b) A photocopy of the birth certificate (not the original).
  - (c) Immunization record
  - (d) The student's most recent report card (unless in Kindergarten).
3. Each student must complete entrance placement tests. The school will notify parents of prospective students of testing dates after applications are completed.
4. After completing Part I of the Pastor's Recommendation Form, give the form to your Pastor. The form is to be submitted directly to the school by your Pastor.
5. Parents of applicants must be interviewed by the School Representative. The presence of both parents is requested.
6. **Upon acceptance of K-12 students, the Registration Fee must be paid for the student to be enrolled.**
7. If parents desire one of the transportation options, the Transportation form (green) must be completed and submitted to the school office.

# High School Application and Registration Procedures

## USING TADS PARENTS MUST:

1. The Student Application must be completed in every aspect and forwarded to the school office along with the application fee and testing fee:
2. The following must be provided for each student that applies:
  - (a) A completed Student Application form and Annual Parent Questionnaire
  - (b) A photocopy of the birth certificate (not the original).
  - (c) Immunization record
  - (d) The student's most recent report card and Transcript
3. Each student must complete entrance placement tests. The school will notify parents of prospective students of testing dates after applications are completed.
4. After completing the top part of the Pastor's Recommendation Form, Teacher's Recommendation Form, and the Administrator Form, give them to the appropriate persons. These forms are to be submitted directly to the school by those people.
5. Parents of applicants must be interviewed by the School Representative. The presence of both parents is requested.
6. **Upon acceptance of students, the Registration Fee must be paid for the student to be enrolled.**
7. If parents desire one of the transportation options, the Transportation form must be completed and submitted to the school office.

# CURRICULUM

## Curriculum

The New York State curriculum is the guide in all subject areas. All subjects are taught with Christian interpretation and understanding.

New York State curriculum is adhered to by each teacher as the basis of information to be learned to keep our students abreast of New York City requirements. At times, the curriculum will be modified by including other areas of emphasis. Evangel Christian School recognizes it is not sufficient to study the principles of God's Word in isolation. Therefore, all curricula are presented in the light of God's Word, the Bible. "The fear of the Lord is the beginning of knowledge." Proverbs 1:7

## **HIGH SCHOOL REQUIREMENTS**

High School Students will be given all required Regents to gain their NYS High School Diploma.

### **High School Graduation/Diploma Requirements**

English – Students are required to take four years of English

Science – Students are required to take four years of Science, along with lab periods

History – Students are required to take four years of History

Math – Students are required to take three years of Math

Spanish – Students are required to take two years of Spanish for Advanced Regents Diploma

Bible – Students are required to take four years of Biblical Instruction

Computer Tech – Students are required to take four years

Phys. Ed. – Students are required to take four years

Electives – Students are required to take one each year

## High School Diplomas Offered and Requirements

**Regents Diploma** – Along with passing all of the above courses the students must receive a 65% or higher on the Global, US History, English, Math and Science Regents (Biology or Earth.)

**Regents Diploma with Distinction** - The same as the Regents Diploma, but all scores on Regents must average 90% or higher.

**Advanced Regents Diploma** - Along with passing all of the above courses the student must receive a 65% or above on the Global, US History, English, three Math, and two Science Regents (Biology and Earth). There is no regents offered in Spanish, but students must pass two (2) years of Spanish.

**Advanced Regents Diploma with Distinction** – The same as the Advanced Diploma , but all scores on Regents must average 90% or higher.

## **Academic Policies and Procedures**

Since Evangel seeks to develop the whole student, attitude, work habit and effort marks are important. They are a measure of the attitude and effort the student is putting forth. They show an aspect of the student that is crucial to his/her success in life and spiritual maturity.

Middle School and High School Mid-term and final exams together constitute 10% of the semester average. Any student who maintains an **overall average** of 96% or above will be given the option not to take the exam. If the students so desires, an exam grade equivalent to the semester average will be awarded.

## **FAILURES**

### **High School**

A final grade of 64 or below in any course constitutes a failing grade and is not recognized for credit. Failed Courses must be made up in a summer program: a) in a summer school provided by your local public school district, b) in a summer school at a private/parochial school, c) in a tutorial program conducted by a professionally certified instructor, d) online course approved by principal. When the requirements have been met, credit will be granted and the grade changed to 65%. Failure to do so will result in the student not being allowed to return to E.C.H.S the following year.

### **Middle School**

In June, a student who received a failing grade in two academic subjects will be required to attend a summer school program: a) in a summer school provided by your local public school district, b) in a summer school at a private/parochial school, c) in a tutorial program conducted by a professionally certified instructor, d) online course approved by principal and to pass the subjects before he can be promoted to the next grade. If that student is in eighth grade, the same requirement must be met for the student to receive his diploma.

If a student fails three or more of the academic subjects, the school will review the student's record in detail to determine if that student should be allowed to remain at Evangel. It may be recommended that he be retained or that he attend another school. He will be given the opportunity of attending summer school, but that will not guarantee his remaining at Evangel or his promotion to the next grade.

### **Elementary Promotion Requirements**

Kindergarten – Students must have developed readiness for the skills required in First Grade for reading and math.

### Grades 1 through 5 –

Students who do not pass the following may be required to be part of a summer remedial program, be retained in their present grade or be transferred to another school:

1. Report Card grades in Reading, Language Arts and Math
2. Stanford Achievement Tests in Reading and Math

### **REPORT CARDS/MID QUARTER GRADES**

All parents are required to meet with their child's teacher(s) at the end of the first marking period: the report card will be explained and the pupil's progress, conduct in the classroom and achievement discussed. However, if a student is having difficulty meeting requirements for his grade at any time during the school year, a meeting will be arranged to discuss the child's progress and ways to assist the child. Testing/Summer School/Retention may be mentioned as a possibility if a student continues to have difficulty. We encourage you to bring any problems or concerns to the teacher. It is our desire that parents and teachers work together in educating the child. Certain minimum academic and behavioral standards must be maintained for a student to continue at Evangel. The school reserves the right to promote, place on probation, suspend, expel or not accept the return of any student who does not meet the standards.

Report Cards are issued 4 times per year – two times per semester. Mid Quarter grades are sent home at the mid-point of each report period only if your child is failing one or more subjects. Please be aware of these reports and assist your child accordingly.

We are also connected to the internet via Plus Portal. Please remember to check your child's homework and test scores weekly.

All new students enrolling at Evangel for the first time will undergo a ten-week Academic Probationary period. The main focus of this period will be the manner in which the student adjusts to the academic program and the type of behavior/conduct demonstrated. A conference will be scheduled with parents when there is a question regarding the ability of the student to meet either of these expectations. *However, the School reserves the right, in its sole discretion, to discontinue enrollment of a new student, at the conclusion of the Probationary period based upon academic performance or conduct and behavior.*

### **Honor Roll**

Students who achieve an average of 96 or better with no grades less than a 90 will be eligible for Principal's List.

Students who achieve an average of 93 or better with no grades less than an 85 will be eligible for High Honors.

Students who achieve an average of 85 or better with no grade lower than 80 will be eligible for Honor Roll.

Students who receive an average of 85 with no grade lower than a 65 will be eligible for Honorable Mention.

# **National Honor Society - Guidelines for Admission**

## **Guidelines for National Honor Society (NHS)**

- ✓ Open to 10<sup>th</sup> through 12<sup>th</sup> grade students.
- ✓ Students must maintain a cumulative average each year of 85% with no failing grades.
- ✓ Students must be in good behavioral standing (no excessive detentions or discipline problems).
- ✓ Students must demonstrate outstanding performance in areas of scholarship, service, leadership and character.
- ✓ Students will meet 4 times a year with their advisor and conduct one service project of their choice.
- ✓ Inductees will be charged for their membership card and pin. 12<sup>th</sup> grade inductees will be additionally charged for an Honor Stole that will be worn at the Induction Ceremony (usually in May) and at their graduation.
- ✓ Inductees can purchase additional merchandise from the catalog on their own.
- ✓ Students must be in attendance at Evangel for at least 3 consecutive quarters or be in good standing with their former school.
- ✓ Students must not have excessive lateness or absences unless they are excused.
- ✓ Be recommended by 2 teachers
- ✓ Must write an essay
- ✓ Show proof of their service

## **Guidelines for National Junior Honor Society (NJHS)**

- ✓ Open to 7<sup>th</sup> through 9<sup>th</sup> grade students.
- ✓ Same academic and discipline standards as NHS.
- ✓ 8<sup>th</sup> grade inductees will be additionally charged for an Honor Stole that will be worn at the Induction Ceremony (usually in May) and at their graduation.

## **Guidelines for National Elementary Honor Society (NEHS)**

- ✓ Open to 4<sup>th</sup> through 6<sup>th</sup> grade students.
- ✓ Same academic and discipline standards as NHS

## **To Remain on NHS, NJHS, NEHS**

The student must maintain an average of 85% , must remain in good behavioral standing and must participate in all NHS, NJHS or NEHS activities and meetings.

## **HOMEWORK POLICY**

Homework is a method of instruction, which emphasizes individual responsibility and personal initiative. All homework assignments must be done neatly and must contain the correct heading and assignment information.

The parents are responsible for making sure their children complete all assigned work. The work must be completed and returned to the teacher to be checked.

Kindergarten and First Grade – Parents must sign each homework

2nd Grade through 5th Grade – Parents must sign homework pad

Parents must help and encourage their children with homework assignments because they are partners with the school in educating their children. Parents can encourage a higher quality of homework by providing a quiet place to study, privacy, freedom from worries and competing interest, no distracting radio and television programs, sympathetic help when needed, and a regular time period for study each day. Generally it is important for the child to work independent of the parent.

Each day students are expected to arrive at their classroom on time and have all school texts, notebooks, folders and other required supplies. Textbooks should be kept covered in grades K-8. Preparing their book bag for the next day is part of the student's homework. A book bag should contain all needed school materials.

## **Absence work**

It is the responsibility of the student/parent to obtain and to promptly do class work, tests, quizzes and homework missed during absence. Students who are absent are requested to check Edline or call a classmate to receive homework assignments.

If, in an emergency, the student cannot complete his assignment on any given night, the parent should send a note stating the reasons. The work will be due the next day. Long-term projects/reports must be turned in on the due date. **Absence is not an acceptable excuse to not complete an assignment. Parents please help your child meet deadlines. Middle School will attend Homework Club during lunch or after school until their work is made up. High School students will attend Homework Club until their absent work is made up.**

While the school supports family members spending time together, it does not look with favor on families taking vacations when school is in session. However, if a vacation must be taken while school is in session, it is required by the state that the teacher be notified in writing.

## **ATTENDANCE POLICY K-12**

The classroom is the center of activity and learning. Regular and punctual attendance is essential for character development. Because of this it is requested that students not be taken out of school unless absolutely necessary. No student can experience maximum growth without the benefit of all instruction, discussion, and assignments. State law requires regular school attendance. Colleges and prospective employers are interested in the attendance records of their prospects. It is understood that occasionally a student may be absent. The following is a list of absences that are categorized as legal by New York State:

**Middle School/ High School**

If your child is going to be absent it is the Parents responsibility to CALL the school between 7:30am to 9:30am and notify the office. If you call before school opens please leave a message at ext. 1401. Failure to do so will result in a call from the administration. Frequent failure to call the school will result in a meeting with the administration.

**Elementary School**

Calling the school to inform us of your child’s absence at ext. 1134 is preferred, however it is not a requirement. You may send a note along with your child the next day they return to school.

Excused Absences

Excused absences include legitimate illness, driver’s test, limited prospective college visits, doctor and dentist appointments which cannot be scheduled outside of school hours, family emergencies, etc.

Upon returning to school following any absence, students are required to submit a note to their homeroom teacher from their parents, which contains the date of the absence, the reason for the absence, and the signature of one parent. If the note does not contain the specific reason for the absence or if a note is not submitted to the homeroom teacher by the third day after returning to school, the absence will be considered unexcused. In cases of unexcused absences, exams will not be made up.

Students are to take full responsibility for making up all work for any legal/excused absence and may expect full cooperation from their teachers. It is the responsibility of the student to obtain and to do promptly, classwork, tests and quizzes and homework missed during absence. Tests assigned in advance and missed through an absence will be taken by the student the day he returns to school. Students who are absent are requested to call classmates/ check Ed-line to receive homework assignments as well as to make arrangements to pick up textbooks.

Excessive absences are detrimental to a student's overall learning experience. Therefore, **ten absences during a quarter** may result in a failing grade for the quarter. A prolonged illness with consecutive absences may result in an "incomplete", "I" and may require summer school. All work needed to clear an incomplete is to be submitted to the teacher no later than five days into the next quarter or the incomplete may result in a failure for the quarter.

**There will be absolutely no tolerance for “Cutting” of classes.** Cutting will be treated very seriously and will warrant an instant suspension and meeting with the parents. Cutting is defined as missing a class without authorization from the Dean, Principal or Vice Principal. If there is another instance of cutting it will be discussed with the school administration and will either lead to an extended suspension or expulsion. Attendance will be taken each period for Middle School and High School.

**LATENESS POLICY**

It is very important for students to be on time because they will miss valuable teaching time. Also, their first class is interactive and cannot be postponed.

**KINDERGARTEN THROUGH FIFTH GRADE**

Students arriving after 8:00 will be marked late. Students are picked up from the cafeteria at 8:00 and school begins promptly at 8:15. Each student should be ready to begin at that time. Those who enter late

miss the first instructions for the school day and disrupt the class that is already in session. Each student will receive 6 excused latenesses per quarter. There may be a meeting scheduled with the Dean with those parents whose child has 10 latenesses in one quarter. If latenesses continue, it will be up to the discretion of the Administration as to whether or not that child will be allowed to remain at Evangel and/or return the next school year.

### **FOR GRADES 6-8**

Students arriving at school after 8:00 will be marked late. Middle School will be given 3 unexcused latenesses per quarter. A typical unexcused lateness is heavy traffic, overslept, etc. When a student receives a fourth unexcused lateness he/she will be assigned a lunch detention. Every lateness thereafter for the quarter will result in a Lunch Detention. Excessive latenesses may result in an Afterschool Detention.

### **FOR GRADES 9-12**

Students arriving at school after 8:00 will be marked late. High School will be given 3 unexcused latenesses per quarter. A typical unexcused lateness is heavy traffic, overslept, etc. When a student receives a fourth unexcused lateness he/she will be assigned a lunch detention. Every lateness thereafter for the quarter will result in a Lunch Detention. Excessive latenesses may result in an Afterschool Detention.

### **FOR GRADES 6-12**

Middle School and High School students arriving to class after the bell has rung will be considered late. There will be a one-minute warning bell that will sound and students are expected to be in class by the next bell, which signifies class has begun. Any child in the hall after the bell must have a late pass. A student arriving to class without a late pass will receive a demerit.

## **ARRIVAL/EARLY DEPARTURE/DISMISSAL**

### **Arrival**

Pupils should arrive at school no earlier than 7:15 a.m. as doors do not open until that time. All students arriving before 8:00 am will report to the cafeteria. After 7:30 am Pre K will report to their classrooms. Kindergarten through 5<sup>th</sup> grade will be picked up from the cafeteria by their teacher by 8:00. MS will be picked up from the cafeteria at 8:00am. High School will go directly to their lockers at 7:55 am.

Parents are not permitted to accompany their children to their classes on the second, third and fourth floors. Parents who do accompany younger students to classrooms on the first floor must sign in and take a Parent Pass to be returned to Security when they leave the building.

### **Early Dismissal**

Pupils may be excused from school **ONLY BY WRITTEN REQUEST** from parent or guardian and approval by the principal. Please place the child's phone number on the excuse note. In addition, your name must appear on the letter. In an emergency parent may call the school.

Other than at regular dismissal times **WE DO NOT ALLOW A CHILD TO LEAVE THE BUILDING** without the signed permission of parent or guardian. **(Note: Even though a child has a signed note, he is not to be dismissed on his own. Parents or guardians must come to the school office where they will pick up their child. For older students, parents must give their permission for the child to leave the building on their own.)**

High School students may not leave the school building during the day. However, those desiring to leave early for justifiable reasons may bring a note from their parent, or have their parent call the office.

In case of illness or emergency, the student will be sent to the office and the office staff/nurse will call the parent to arrange transportation.

Students will not be excused from scheduled classes for work commitments. No arrangements will be made for the regular dismissal of students.

## **Internet Policy**

Use of the Internet provides great educational benefits to students. We have our own filtering server, which uses artificial intelligence, provided through Integrity On Line, a Christian filtering service. All sites are blocked at the Service Provider. Access to the Internet is given as a privilege to students who agree to act in a responsible manner. We require that students, and parents or guardians, read, accept, and sign the following rules for acceptable on-line behavior.

1. Students are responsible for good behavior on the Internet, just as they are in the school building. It is their responsibility to use the Internet wisely.
2. All usage shall be purposeful and appropriate to the Mission Statement of Evangel Christian School.
3. It is understood that computer use and Internet access for students is a privilege, not a right. Computer misuse while on campus, can subject the student to loss of the privilege of future use of any school computers or equipment but also more serious discipline, up to and including suspension and expulsion.
4. The communications services and equipment at the School (including, but not limited to, telephone, fax, photocopy machines, computer network, computer files, and internet access or use) are School property and should be used only for appropriate purposes. Accordingly, the School may intercept, monitor review, or disclose any use of communication systems at the School, as it may select. Messages sent or received, materials or websites viewed, files created, or any use of the School's communications system or equipment is not a student's private property and a student has no ownership rights in such materials or expectation of privacy in the use of the School's communications services and equipment. Students do not have any expectation of privacy in any communications or files created, stored, sent, viewed or received upon the School's communication services and equipment, regardless of whether the materials, files, or communications are intended or designated as private.
5. The School reserves the right to monitor at any time, without notice, any student's use of any of the School's communication service or equipment. This includes, but is not limited to, installing programs that monitor a student's use of the internet and electronic communications, and to take disciplinary action based upon any violation of expected conduct standards discovered.

**6. The following are not permitted:**

- Accessing inappropriate material
- Use of inappropriate language
- Plagiarism
- Trespassing in another's folders, work, or files
- Employing the network for commercial purposes
- Damaging computers, computer systems, or computer networks
- Using another's password

- Receiving or sending E-mail
  - Chatting in chat rooms
  - Instant messaging
  - Posting information of any kind
  - Going to sites other than those directed by the teacher
  - Violating copyright laws
  - Downloading and installing programs, applications, files, or information without permission.
  - Use of the Internet without a faculty member present
  - Not respecting copyright laws and licensing agreements pertaining to material obtained via the Internet.
  - Using the network for personal profit or gain, commercial activities, product advertisement, and political lobbying is prohibited.
7. Vandalism or intentional modification of system settings will result in cancellation of privileges and/or disciplinary action. The school reserves the right to seek financial restitution for any damage caused by inappropriate use. The Administration will deem what is inappropriate use and their decision is final.

## **SPIRITUAL LIFE**

Evangel Christian School is committed to the proposition that the primary relationship a human being may have is with the person of Jesus Christ. Therefore, the school actively pursues with students their personal commitment to Jesus Christ.

Formally, Christian instruction takes place in each classroom at the beginning of the day through devotions and prayer, in each class through the integration of faith and learning, and specifically in the Bible classes and in the weekly chapel program. Outside speakers, films, faculty, parent and student speakers and pastors all contribute to the leadership and enrichment of this worship time. An offering may be taken during chapel to be used to help those in need on the mission field and in our own community. At present, Evangel sends money to help in various orphanages, assists in programs for the homeless in New York City and gives an offering to missionaries and ministers who speak at our chapel services.

Evangel School is also very active in, and committed to, outreach and missions. Through outreach, we believe that students can develop the God given talents He has blessed them with. Outreach also causes one to realize that God can use a willing heart no matter what the age.

### *Christian Service Programs for Middle School and High School*

The Christian Service Program for students will be integrated throughout the curricula and emphasizes helping and serving in the life of a Christian. Through this program we hope to instill in our students the following qualities:

- 1) a greater awareness and acceptance of their relationship to serve God and their fellow man
- 2) an increased knowledge of the opportunities for service
- 3) an increasing sensitivity to the needs of others
- 4) an increasing manifestation of those attributes of God such as love, mercy, sympathy, justice, and joy in their own lives, and the ability to effectively direct these traits through service to others.
- 5) a measure of growth that will produce a more Christ-like young person better able to be salt to the human condition.

**Middle School students must complete 50 hours of Ministry by graduation day. High School students must complete 100 hours of Ministry Hours by graduation day. If students enter after Freshmen Year they must complete 25 hours per year.**

Students complete a Christian Service form for each type of service he or she performs. The type of service requires approval by the principal before service is performed. Upon completion, service forms are submitted to the principal. Service may be in the form of local church ministries, community service, tutoring, assisting in afterschool, school maintenance projects or other school/community outreaches.

## **DISCIPLINE POLICIES OF EVANGEL SCHOOL**

**We believe in discipline. The school is best able to provide an enriching, enjoyable and constructive educational experience for each student by maintaining a positive and disciplined learning environment where consideration is given to each person's needs. It is our goal to provide the proper learning environment for students. It is the student's responsibility to make a commitment to live within the rules and regulations that are necessary for us to function together each school day in a God-honoring manner. It is the parents' responsibility to support and encourage their children and staff in the meeting of this goal. Discipline can be defined as training for self-control. A child should sense the responsibility to control himself as a mandate from God.**

**We believe in respect. At all times when associating with teachers, staff and peers, students should practice respect courtesy, and consideration. The student should respect the authority of teachers, administrators and staff members and respond to them obediently and respectfully as unto the Lord. The teacher and staff must have respect for the child.**

**We believe in the teacher. The teacher is the authority figure that sets the positive and constructive tone for self-discipline and control in the classroom. The teacher should instill ideas of good conduct in the minds of the pupils.**

## **GENERAL STANDARDS OF STUDENT CONDUCT**

As a Christ-centered school, ECS desires that every school employee and student reflect a lifestyle pleasing to Jesus Christ. Because of this, who we are and what we do, both on and off campus are extremely important. Realizing that students are representatives of the School and that the expectations of Biblical behavior are not limited to a specific time or location, expected conduct standards apply to students both in and out of school and whether on campus or away from campus. Although many of the student conduct standards address behavior at school or school related functions, parents understand and agree that a student's conduct away from campus and outside of school hours can result in disciplinary action.

Evangel Christian School is committed to helping its students to develop Christian character and believes that the daily study of the Word of God is essential in order for this development to take place. The Bible expresses the basic principles of conduct in the Ten Commandments and through the Word of God. Among these are honesty, respect for one another, for property and authority, a sense of community, stewardship of time, money and talents, self-control and creativity. In accordance with Scripture, each student is considered responsible for his or her own behavior. In acting responsible, the student will observe all of the school rules and respect the rights of others.

What we say and do not only affects each of us personally, but also those around another.

To accomplish the School's disciplinary goals, certain behavior by students cannot be tolerated and will result in action by the administration and/or the teacher. Students are expected to:

- Strive for excellence as a student in all that they say and do

- Obey Biblical principles with regard to speech and conduct
- Tell the truth and avoid engaging in deceptive or dishonest behavior
- Show respect and cooperate with those in authority at the school. Students are to listen and to obey school authorities (i.e. teachers, staff and administrators). Defiance or insubordination of authority is not permitted.
- Refrain from the use or possession of alcohol, illegal drugs and tobacco. Students may not possess drug paraphernalia.
- Dress in accordance with the guidelines set forth by the School's dress code policy
- Comply with the discipline policy of the School.
- Use appropriate non-violent means to resolve any conflict. Students should keep their hands off other students at all times. Any form of aggressive behavior, such as bullying, insults, threats, inappropriate teasing, and harassment are demeaning to other students, disruptive to the educational environment and are not tolerated.
- Strive to complete all assignments on time and to the best of their abilities and demonstrate academic integrity in all assignments and course work. Plagiarism, cheating, and academic dishonesty are not tolerated.
- Engage in conversation which is appropriate and honoring to God. Profanity, course joking, bullying, inappropriate language or innuendoes are not acceptable.
- Respect the personal property of others. Students should leave the property of others alone. Destruction, damaging, tampering with or the theft of another individuals or the School's property is not tolerated.
- View other students as brothers and sisters in Christ.
- Respect the emotional, spiritual and physical integrity of themselves and others.
- Refrain from engaging in any actions that compromise the safety of other persons or the School. Students are not to bring any weapons to School.
- Abide by the other policies set forth herein, including, but not limited to the policies prohibiting harassment, prohibiting threats of violence and prohibiting possession of any weapons at the school or its related activities.
- Be courteous, cooperative, and accepting of instruction and discipline.
- Abide by the Biblical Morality Standards and Policy set forth below. Students may not engage in any sexual misconduct.
- Refrain from creating any web page, web site or making online postings that contains objectionable material. Objectionable material includes, but is not limited to: sexual content, material that consists of profanity, cultic/occult material, gang related content, material that threatens another, material that is damaging to another's character/reputation and/or puts another in a "bad light". Objectionable material is anything or anyone that goes against God's Word or promotes an anti-Christian lifestyle. Students also may not use Evangel Christian School's name in conjunction with any web site or web page that contains objectionable material. (see above)
- Refrain from participating in or the appearance of participating in any gang related activity.
- Avoid any other conduct, or the appearance of any of the above items, which brings discredit to the School or students, or violates the schools biblical teachings or standards.

**Students must never do or say anything that makes it appear that they are involved in or have been involved in, or have done and/or are doing any of the above.**

*\*\*\*These obligations apply to all students and failure to comply with any of the above will result in disciplinary action and may be cause for suspension or immediate dismissal.*

### **Biblical-Morality Policy**

**Evangel Christian School's Biblical role is to work in conjunction with the home to mold students to be Christ-like. Of necessity, this involves the school's understanding and belief of what qualities**

or characteristics exemplify a Christ-like life. The school reserves the right, within its sole discretion, to refuse admission of an applicant or to discontinue enrollment of a student if the atmosphere or conduct within a particular home or the activities of the student are counter to or are in opposition to the Biblical lifestyle the school teaches. This includes, but is not limited to, participating in, supporting, giving the impression of, or condoning sexual immorality, homosexual activity, or bisexual activity; promoting such practices; or being unable to support the moral principles of the school. (See Leviticus 20:13 and Romans 1:27)

**\*Evangel expects students to honor Christ in all behavior and activities twenty-four hours a day; seven days a week; three hundred and sixty-five days a year.**

**All school rules apply on all field trips and on all school-sponsored events on the school campus and away from it.”**

Student’s that have been arrested/apprehended, or put on probation by the Justice System BEFORE applying to Evangel or DURING the school year, or between school years, will not be allowed to attend ECS. The final decision will be up to the discretion of the School Board.

**Students must never do or say anything that makes it appear that they are involved in or have been involved in, or have done and/or are doing any of the above.**

*\*\*\*These obligations apply to all students and failure to comply with any of the above will result in disciplinary action and may be cause for suspension or immediate dismissal.*

### **POLICY FOR VERBAL/PHYSICALHARRASSMENT**

ECS is firmly committed to providing an environment, in which all students, regardless of gender, race, or national ethnic origin, can work, study and play without fear of harassment. The environment at the School must be one in which all individuals are free to work, learn, and develop relationships without fear of intimidation and humiliation, as a result of unwanted or unacceptable behavior from others. It is essential to the well-being of all that students, parents, teachers, and staff members treat each other with due respect for rights, individuality, and personal dignity.

Definition of harassment may include the following:

- Sexual Harassment consists of unwelcome sexual advances, request for sexual favors and other inappropriate verbal, non-verbal, written, graphic or physical conduct of sexual nature. Sexual harassment, as defined above, may include, but is not limited to the following: verbal, graphic and written harassment or abuse, pressure for sexual activity, remarks to a person with sexual or demeaning implications, unwelcome or inappropriate touching or exposure of body parts, suggesting or demanding sexual involvement accompanied by implied or explicit threats concerning one’s social or academic standing, explicit pictures, posters, calendars, etc. in class notebooks, lockers, etc.
- Racial harassment consists of all forms of discrimination related to – race, color, and national origin, including any verbal, non-verbal, graphic, written or physical conduct that denigrates or shows hostility or aversion toward any person based upon race, when such conduct interferes with a student’s academic performance or creates an intimidating, hostile or offensive school environment. Racial harassment may include, but is not limited to, the following conduct which is based upon race: Epithets and slurs, negative stereotyping, threatening, intimidating or hostile acts, written or graphic material that stirs hostility or aversion toward an individual or group.
- General harassment/bullying consists of using unwelcoming gestures, words or written statements to annoy, demean, denigrate, defame, malign or ridicule another person.

Among the behaviors that are strictly prohibited are:

1. obscene or suggestive remarks, jokes, gestures, pictures or drawings
2. threats, bullying or any other forms of intimidation
3. demeaning comments with respect to race, ethnic origin, gender
4. behavior of a sexual nature that makes a student feel uncomfortable
5. touching another student in any way that makes them feel uncomfortable
6. Play fighting, or any form of hitting

If a student believes they have suffered harassment or that a violation of this policy has occurred, they should complain to any member of the school faculty or Administration, who will then promptly report it to the School's chief Administrator.

Please Note: All incidents will be treated in the strictest confidence. In determining whether the alleged conduct constitutes a violation of the harassment policy, the administration will evaluate the totality of the circumstances surrounding the conduct. The following facts should be considered: the ages of the parties involved; the nature, severity and scope of the behavior; the frequency and duration of the behavior and the context in which the conduct occurred. Harassment will be treated very seriously and severely. Harassment, physical abuse and verbal abuse will not be tolerated. It will be up to the discretion of the Administration as to the punishment; considering all the factors suspension and/or expulsion will be possibilities.

## **THREATS OF VIOLENCE AND WEAPONS**

ECS seeks to promote a healthy, safe learning environment. ECS does not tolerate threats of violence to oneself, others, threatening behavior or other acts of violence (including threats to severely damage school property or the property of other students) whether made in school or out of school. Any threats or depiction of violence or harm, whether specific or general, whether alleged to have been a "joke" or serious, whether in school or out of school, whether in person or through some other method of communication (e-mail, IM, message board, internet posting, letter, picture, etc.) will be taken seriously by the School and may be grounds for immediate discipline, including suspension or expulsion. The School may suspend or expel the student, following such conduct or may, in its sole discretion, depending upon the facts and circumstances, condition continued enrollment upon satisfaction of additional criteria, which could include certification from a mental health professional and consistent monitoring by a mental health professional. Nothing contained herein, however, shall in any way limit or prohibit the School in its sole discretion, from suspending, expelling, or removing any student who violates this policy.

Parents and others will be encouraged to report any such incidents or information to the appropriate official. Staff shall immediately notify an administrator of any threat, threatening behavior or act of violence he/she has knowledge of, has witnessed or received. All reports will be promptly investigated.

Students are prohibited from possessing, handling or using, whether concealed or open, any weapon, or any instrument that reasonably looks like a weapon or could be used as a weapon. Weapons include, but are not limited to, all of the following:

- Loaded or unloaded firearm, including a gun, pistol or rifle
- Explosives, including a dynamite cartridge, bomb, grenade or mine
- Knife, including a pocket knife, bowie knife, switchblade, dirk or dagger
- Slingshot
- Blackjack
- Metal knuckles
- BB gun
- Air rifle or air pistol
- Stun gun or other electric shock weapon

- Any sharp pointed or edged instrument
- Razor or razor blade (except solely for personal shaving)
- Fireworks

Should a visitor be caught in possession of a weapon, the administration shall notify law enforcement officials which could result in criminal charges if local, state, and federal laws have been violated.

No student may knowingly or willfully cause, encourage or aid any other student to possess, handle or use any of the weapons or weapon-like items listed above. A student who finds a weapon or weapon-like item, who witnesses another student or other persons with such items, or becomes aware that another student or other persons intends to possess, handle or use such items, must notify a teacher or the principal immediately.

## **CLASSROOM STANDARDS OF STUDENT CONDUCT**

Students are expected to show respect for authority and for one another. At Evangel, this includes faculty, staff and peers. A student is expected to show concern and respect for the person, rights and possessions of others. A student is expected to arrive at class on time with the appropriate textbooks and required materials. In the classroom, **students are to demonstrate self-control, compliance with the teacher's directions and avoidance of anything that will disrupt the teaching-learning process.**

**Therefore, the following behaviors are unacceptable:**

1. Talking in class without permission
2. Not sitting properly for instruction
3. Passing notes
4. Throwing objects
5. Harassing fellow students
6. Unacceptable noises and/or gestures and distractive activity
7. Impertinence or defiance to a teacher or another adult
8. Leaving seat or classroom without permission
9. Coming to class after the late bell has rung without a late pass.
10. Disruptive Behavior
11. Explosive/Angry Behavior

School Rules include but are not limited to the following:

1. Gum chewing is not permitted in the school.
2. Media Devices such as PSP's, Video Games, MP3's, iPOD's, Game Boys, are not to be seen or heard in the school. These items must be placed into book bags before entry into the school. If they are seen or heard they will be confiscated and searched. They will receive a detention after school for having the audio equipment out. No secular Tapes/CD's/Music/Digital Music or Video Files are to be brought into the school by students. **There is to be no objectionable material downloaded on the student's audio equipment: including, but not limited to: pictures, music, etc.**
3. Comic books and literature of a non-instructional nature should not be brought to school.
4. Students are not to have in their possession material that is sexually explicit.
5. Hats/coats/scarves/mittens and gloves or head coverings are not to be worn indoors.
6. Students are responsible for classroom and hallway orderliness.
7. High School and Middle School **Cell phones** are to be placed in the student's lockers. They are not allowed to take them out on school grounds. Any student that is found with a cell phone in their possession will have the cell phone confiscated and it may be searched. The cell phone will only be given back to the parent or guardian. Cell phones are not allowed to be stored in students: book bags, purses, jackets, coats, pants pockets, etc. The school is not responsible for lost or stolen cell phones. Cell phones are to remain in student's lockers. **There is to be no**

**objectionable material downloaded on the student's cell phone: including, but not limited to: pictures, music, etc.**

8. Students are responsible for keeping classrooms clean and orderly.  
No books or other items are to be found on the floor.
9. No student can be out of the classroom without permission and a pass or note.
10. Students should have no physical contact with the opposite sex. Public displays of affection are not allowed.
11. Students should not be involved in negative physical contact such as pushing, shoving, hitting or play fighting.
12. Negative paraphernalia of any type adorning book bags, books, clothing, such as patches, stickers etc. will not be allowed in the school. This includes any gang related paraphernalia. Negative paraphernalia encompasses anything or anyone that promotes an anti-Christian lifestyle, and/or anything that goes against God's Word. Only positive paraphernalia will be allowed. It will be up to the discretion of the Administration to decide what is allowed.
13. Students are not to publish, circulate or distribute any written material to the student body, staff, and/or parents without the permission of the Administration. The school administration has the right, in its sole discretion, to control what is published, circulated, or otherwise distributed to students or staff.
14. The school phone is only to be used in case of an emergency. It is not to be used for ordering lunch.
15. Stickers, tape, and permanent items are not to be placed in lockers. Any pictures are to be put up with Fun-Tak
16. Gambling is not permitted.
17. Fireworks, of any kind, should never be brought to the school.

## **MS/HS Lockers**

**Student lockers and any other storage areas at all times are the property of Evangel Christian School and are provided as a convenience for students to store their belongings.** Students do not have any expected privacy to their lockers or student desks or to any materials stored within their lockers or desks. The School reserves the right, at any time without prior notice, in its sole discretion, to search student lockers. For purposes of this policy, student desk searches will be treated in the same manner as student lockers.

Students must understand clearly the following guidelines:

### **Locker Guidelines**

1. Students should not switch lockers with another student. If a student uses a locker, it must be the one to which that student was assigned. Students who violate this rule will be subject to disciplinary action.
2. Students must not share their own locker combination with any other student. This combination is given to them in confidence. What they do with it is their responsibility. Allowing others – even friends – to know a locker combination is the greatest cause for loss of personal items from lockers.
3. Lockers may be inspected and searched at any time by the administration.
4. Lockers must be kept clean inside and out.
  - a) Stickers are not allowed on any part of the lockers.
  - b) Students must not place anything on the lockers that they cannot easily remove without affecting the surface of the locker.
  - c) Student must not post any objectionable material inside or outside their locker. including, but not limited to: pictures, music, etc.

5. Students should not enter anyone else's locker without permission from the student who is assigned to that locker. A staff member with a locker key must be present to open the locker.
6. Students are responsible to pay for any locker damage they do in violation of the above rules.
7. Violation of any of the above rules can result in temporary or permanent suspension of locker privileges, and further disciplinary action.
8. Any problems with a locker should be reported to the office or to a designated staff member.
9. The school is not responsible for lost or stolen, or damaged goods belonging to students.

## **STUDENT SEARCHES**

Search of Students – If the School has a reasonable suspicion that a student has prohibited items or evidence of a violation of the student conduct standards or contraband items on his person, book bag or other similar item, a school Administrator, with another school employee, may ask a student to empty his/her pockets, purse, book-bag and/or to take off their shoes and socks. If the student is unwilling to do so, the Administrator will contact a parent/guardian. If the student is still unwilling to do so after having spoken with his/her parent/guardian, and the parent/guardian is unwilling to do so, then the School will assume that the student has the prohibited material or has engaged in the conduct alleged and proceed to take appropriate disciplinary action, which may include suspension or expulsion from the School.

## **DISCIPLINARY PROCEDURE FOR CONDUCT**

**Although the School follows the general guidelines below, all consequences are at the discretion of the teacher and Principal as to the proper level of the offense. The School reserves the right, based upon the specific facts and circumstances, nature of the offense, history of prior misconduct, student attitude, and other factors, in its sole discretion, to by-pass any general or progressive discipline procedure and proceed to more severe discipline, up to and including, suspension or expulsion.**

All new students enrolling at ECS for the 1<sup>st</sup> time will undergo a 10 week Behavioral Probation Period.

### **PreK – 2<sup>nd</sup> grade**

Use the Dot System. The child begins each day with a Green Dot. If the child is misbehaving his dot will be changed to Yellow. This is only a warning and lets the student know that he/she needs to change his/her behavior. If the child changes his/her behavior and obeys the teacher, his/her dot will be changed back to Green. If the behavior continues their dot will be changed to Red. This means that the child will receive a period of "time out" to allow them some time to change their behavior. If their behavior is rectified after the "time out" their dot will be changed back to Green. If the behavior continues after the "time out" they will receive a Purple Dot and will be taken to the Dean's Office. There the Dean will contact the parent and he will decide whether or not the parent must come and pick up the child.

### **Pre-school**

At the 4<sup>th</sup> Purple Dot a meeting will be arranged with the Parent's and the Dean to discuss the child's behavior and possibilities for rectification. At the 8<sup>th</sup> Purple Dot another meeting will be arranged with the Dean to determine whether or not the student will be allowed to remain at Evangel.

Pre-school is not mandatory by law and not all children are ready to attend school at 3 and/or 4 years old.

### **Kindergarten through 2<sup>nd</sup> Grade**

At the 4<sup>th</sup> Purple Dot a meeting will be arranged with the Parent's and the Dean to discuss the child's behavior and possibilities for rectification. At the 8<sup>th</sup> Purple Dot another meeting will be arranged with the Dean and a possibility of Behavioral Contract drawn up. At the 12<sup>th</sup> Purple Dot or breach of Behavioral Contract the child will be a suspended or expelled from the school.

### Third through Fifth Grade

Uses the Mark System. The issuing of a demerit is a corrective step to bring about change. Along with the actual assignment of the discipline slip, an advisement time follows between teacher and student. This time must conclude with the student's understanding of the wrongdoing and his/her assurance that there's no intention of repeating the offense. The student may be asked to get a parent's signature on the MARK slip and return it to the teacher the following day. This enables the parents to get involved in the corrective process immediately..

If the student is exhibiting negative behavior the student will be warned by having their name written on the board. If they continue and do not stop they will receive a mark next to their name this will result in them receiving a Recess Detention. If the student receives 2 marks in a five day period they will receive an afterschool detention. For a serious offense, or pattern of misconduct, instant detentions, suspensions, or expulsions may occur. Please see page 16 for serious offenses.

### Middle School and High School

Use the Demerit System. **If a student receives two demerits from one teacher within a 30 day period, he/she will serve a one-hour behavior detention after school from 3:10pm to 4:10pm the day of for High School; for Middle School the detention needs to be served by the next day.** A detention form is filled out by the issuing teacher noting behavior as the reason for the detention.

The issuing of a demerit is a corrective step to bring about change. Along with the actual assignment of the demerit slip, a counseling time follows between teacher and student. This time must conclude with the student's understanding of the wrongdoing and his/her assurance that there's no intention of repeating the offense. The student may be asked to get a parent's signature on the demerit slip and return it to the teacher the following day. This enables the parents to get involved in the corrective process immediately. A student who fails to return the signed slip on time will be penalized with an additional demerit thus giving him/her a detention.

There are 3 levels of evaluating misbehavior: 1<sup>st</sup> - Demerit 2<sup>nd</sup> - Detention 3<sup>rd</sup> - Suspension

***\*Demerits will be given for the following infractions, but are not limited to the following:***

- Late to Class without Late Pass
- Chewing Gum
- Making Noises or Calling Out during class
- Talking at inappropriate times during class
- Passing Notes
- Throwing Objects
- Anything that the teacher has warned the student to stop doing and the student continues to do

**\*Instant detentions or suspensions will be given for the following infractions, but are not limited to the following:**

- Cutting Class
- Use of Profanity
- Misconduct in Chapel
- Misuse or Altering of Passes
- Cheating on Homework or Tests
- Leaving Class Without Permission
- Leaving School Property Without Permission
- Dress Code Violations that are blatant and/or involve immodesty
- Disrespect
- Lying
- Disobeying School Rules
- Receiving Two Demerits from one teacher
- Any of the previously listed offenses that continue after receiving a detention for them

**\*A suspension or immediate dismissal (disenrollment) will be assigned for the following list of infractions, but are not limited to the following:**

- Harassment
- Threatening another student
- Truancy
- Stealing
- Immorality
- Destroying or Defacing School Property

- Possession or Use of Tobacco Products
- Possession or Use of Alcoholic Beverages
- Possession of Guns, Knives or Weapons of any kind
- Possession of Drug Paraphernalia
- Irreverence for the Things of the Lord
- Defying a Teacher
- Fighting
- Assaulting someone (verbally or physically)
- Putting material on-line that is Objectionable: Objectionable material consists of, but is not limited to: Material that includes sexual content, material that consists of profanity, cultic/occult material, gang related content, material that threatens another, material that is damaging to another's character or puts another in a "bad light". Objectionable material is anything or anyone that goes against God's Word or promotes an anti- Christian lifestyle harmful to another's reputation/character and/or puts the student in a negative light
- Possession of any Questionable Material, Printed or Electronic  
Objectionable material consists of, but is not limited to: Material that includes sexual content, material that consists of profanity, cultic/occult material, gang related content, material that threatens another, material that is damaging to another's character or puts another in a "bad light". Objectionable material is anything or anyone that goes against God's Word or promotes an anti- Christian lifestyle.
- Being arrested/apprehended or put on probation/parole by the Justice System for any offense
- Attending dance clubs/ bars
- Blatant disregard of ECS Rules and Policies

The Dean of Students and Discipline Committee are responsible for all issues concerning behavior. The Teachers are the authority in the classroom and will report all Purple Dots, Marks, demerits and detentions to the Dean. If need be, the Dean will contact parents of students with behavioral issues. Any repetitive behavior resulting in suspension or expulsion will be brought to the attention of the Discipline Committee. The Discipline Committee consists of the Principal, Assistant Principal, and the Dean of Students and School Board members.

### **3<sup>rd</sup> through 12<sup>th</sup> grade - Readmission**

At the end of the suspension period or at the time of readmission the student is automatically placed on 4 weeks of probation beginning at the time of readmission. The policies regarding probation then apply.

### **Probation**

Behavioral Probation remains in effect for one year. During this time the student will be evaluated every four weeks to ensure that the student is meeting all requirements for attending Evangel Christian School. Probation gives the student the opportunity to correct his/her problem. If he/she does not improve to a satisfactory level, he/she will be expelled or asked to withdraw from the school, or asked not to return.

At all times the School reserves the right to by-pass any general or progressive model of discipline, in its sole discretion, and proceed to more severe discipline, up to and including, suspension or expulsion.

## **DRESS CODE**

**Evangel uses Land's End as our uniform provider. All options are listed on their website under Evangel Christian School. You can either buy the uniform from one of their stores, or try samples on at Evangel and purchase on Land's End's website.**

### **DRESS CODE for Grades 1 through 5**

The school colors are navy and gold. Following is the standard uniform policy:

Shoes: Black shoes

Jumpers: Plaid with a plaid tie. Jumpers no shorter than knee length.

Shirts: Yellow or hunter green. Shirts may be long sleeved or short sleeved.

Slacks: Navy blue.

Ties for Boys: Navy blue or plaid.

Socks: Navy blue or white

Sweaters: All sweaters need to be hunter green.

\* Yellow or hunter green school polo – long or short sleeved with the school insignia

\*Gym Shorts: Bright Blue

\*Gym Shirts: Bright yellow or bright blue with Evangel Inscription

\*Hoodies: Bright blue with Evangel Inscription

The above items **may be purchased from Evangel, the Ideal Uniform Company or Cookies.** \*These items purchased through the school office.

**NOTE: Wearing of the school uniform is not mandatory for Pre-Kindergarten or Kindergarten. IT IS REQUIRED THAT ALL SCHOOL CLOTHING BE LABELED WITH THE STUDENT'S NAME.**

**Elementary School** - Parents are responsible to make sure that their children come to school in proper uniform. If the student comes to school numerous times out of uniform a meeting will be arranged with the Dean.

### **CLASS UNIFORM Middle School/High School**

**High School** – Unless accompanied by a note from parents, “out of uniform” infractions will result in a 30 min. A/S Detention

**Middle School** - Unless accompanied by a note from parents, “out of uniform” infractions will result in Lunch Detention

**MS/HS** Proper uniform must be worn at **all** times. The School ID is part of the school uniform. A girl that is caught rolling up her skirt more than three times will be asked to wear pants for the remainder of the year.

Gym uniform must be purchased in the school office. PreK through 8<sup>th</sup> grade will wear their gym uniform to school on the day that they have gym. High School students will not wear their gym uniform to school. They will change in the locker rooms and after gym they will change back into their uniform again. Please come prepared for gym on the appropriate days.

## ECS DRESS Code

The following Grooming and Dress Code reflects the conviction of Evangel Christian School that a Christian's appearance is an important part of his/her testimony. The collective appearance of the students is also an important part of the school's corporate testimony. Modesty, appropriateness, Biblical guidelines, neatness and moderation are the basis of the formulation and interpretation of the Dress Code. The following is a result of years of definition, regular evaluation, and prayerful consideration.

1. Parents are expected to ensure that their child(ren) are dressed properly (in accordance with the school's dress code) and clean and neat looking when the student leaves for school or participating in a school activity. When students are not in uniform, they must have a signed note to explain any emergency circumstances, or the parent must call the school and inform the Administration.
2. All students who wish to wear a sweater in school must wear the appropriate ECS sweater with embroidery. It may be a crewneck, V-neck or cardigan. It may not be a fleece or sweatshirt type. Sweatshirts may be worn only on gym days. Sweatshirts may not be worn with the regular school uniform. No outdoor jackets and/or hats may be worn in school.
3. On gym days the class uniform is to be worn to school and students will change in the locker room into their proper gym uniform proper (see above).
4. **Shoes are to be black. They are not to have any light colored markings or material on them.**
5. Girls are not permitted to wear large, dangling earrings that hang below the jaw and **on gym days, only small and not hoop or hanging earrings are to be worn. A student with hanging or hoop earrings will not be allowed to take part in the gym activities and will be marked unprepared.** Only 2 earrings on the earlobe will be permitted. No ear cuffs or earrings any other place than the earlobe will be allowed.
6. In colder weather, the girls may wear PreK-5<sup>th</sup> navy, MS maroon or grey tights, HS grey or navy and the same color socks. **No other color leggings or socks will be allowed.** In extreme cold the student may wear ECSA sweatpants, will need to change immediately upon entering the building.
7. All necklaces must be worn inside shirt or blouse.
8. For purposes of modesty (I Timothy 2:9) uniform skirt lengths must be knee length. The skirt length standard will apply regardless of growth experienced during the year.
9. The wearing of work shoes, beach footwear (flip flops) and work boots is prohibited. Shoes must be kept clean and in good repair. Shoelaces must be tied.
10. Students are to remain in proper school dress while they are in the building.
11. Tattoos are no allowed to be seen
12. Body modifications, of any kind, are not allowed
13. Students are not allowed to write on themselves or anyone else with markers – permanent or washable
14. Boys are not permitted to wear any earrings or ear cuffs. They are not allowed to wear nail polish or make-up of any kind.
15. Jewelry (bracelets, collars, etc.) that contains metal spikes is not allowed. Large jewelry, of any type, is not permitted.
16. Girls are allowed to wear navy, grey stockings, nude stockings are not allowed with their skirt. If they wish to wear knee-highs they must be navy or grey. If they wish to wear anklets they must come up to the ankle and be navy or grey.
17. Students must come to school in uniform. Students are not allowed to come to school in street clothing and change in the bathroom. At the end of the school day, they must leave the school building in school uniform, unless they are participating in an after school activity, with permission from the teacher. ***Students need to be in full uniform within a 5-block radius of the school.***

18. Sunglasses and unusual contacts that will give an appearance other than the normal eye are not allowed.
19. Belts must be worn with pants and must be blue, black or grey with no adornment other than a plain belt buckle.
20. Attention should be given to apparel neatness. All apparel should be clean, neat and whole.
21. Bodily grooming should be exhibited by general cleanliness and neatly cut, trimmed and combed hair. Extreme hairstyles (as determined by the administration) are prohibited
22. Boys must keep their hair trimmed and neat. Excessively long hair, sideburns, locks, ponytails, shaved heads, hair sculpting by shaving, braiding, dying or streaking/highlighting hair extreme or unnatural colors, large/long spikes are not permitted. Sideburns must not extend below the base of the ear. **Hair must be off the collar and out of eyes. Hair cannot completely cover the ears.** Boys must be cleanly shaven or have a trim beard. Boys cannot shave their eyebrows in a pattern. Mohawks, fauxhawks, or the like, are not allowed. Afro's cannot be longer than 2 inches. Boys eyebrows must be naturally shaped. Girls are not allowed to highlight or dye their hair unnatural or extreme colors.
23. Girls are permitted to wear moderate amounts of make-up (lip gloss, mascara and light blush). No make-up is permitted which draws attention to itself or which is not natural in appearance.
24. Body piercing of any kind will not be permitted (nose, tongue, eyebrow, belly button, etc.)
25. Body jewelry of any kind is not permitted.
26. The spraying of perfume or cologne is not permitted in the school; it must be done at home before coming to school. The use of deodorant is permitted in the gym locker rooms only
27. MS/HS students must wear their ID's at all times. They must not deface their ID in any way or manner. Their name and picture must be visible at all times.
28. Jeans are not allowed to be worn underneath clothing

While uniforms are not required at recreational activities, students are required to dress appropriately, modestly, and in a manner which is compatible with the testimony and standards of the school. The following are examples of apparel which are NOT permitted for student participants or observers at any school functions: Short skirts, short shorts, tight fitting apparel, cut-off shirts or apparel which bares the midriff, immodest apparel of any type, jeans, apparel with inappropriate advertising.

## **SCHOOL INSURANCE POLICY**

Any insurance coverage afforded by any policy is a SECONDARY. All claims must first be filed with the family's insurance company.

## **EMERGENCY SCHOOL CLOSING**

If it is necessary to close the school due to inclement weather or other emergency, there will be an announcement on the school phone, twitter, facebook, and the school web site. Whenever city schools are closed due to an emergency, Evangel Christian School will be closed. Any parent is welcome to remove a child from class early if weather conditions are such that the safety of the child traveling home at dismissal time is in question. For younger students, please put in writing who your child may leave school with should it become necessary to close early.

## HEALTH

Physical exams are required for all new students and those students going into 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup>, 9<sup>th</sup>, and 11<sup>th</sup>. All students should have a dental exam once a year.

### ***Required Immunization for School Admission:*** Diphtheria, Poliomyelitis, Measles, Rubella, Mumps, HIB

For all newly admitted children at any level, the principal must require that **one** of the following conditions be met in relation to diphtheria, poliomyelitis, measles, mumps and rubella before admission:

1. A certificate or written statement by a physician or parent that the child is adequately immunized or is in the process of receiving immunization (or, in the case of measles), setting forth the dates and type of vaccine administered insofar as the information is available; or
2. A written statement by a physician that immunization is medically contraindicated or a statement by the parent that he objects to the immunization of his child on religious grounds.
3. A complete packet listing all health requirements is available for every parent.

If your child acquires a communicable disease, please call the office immediately. We must know the health condition of the school children in order to send warning notices to parents advising close watch of each child for possible symptoms. Check your children daily for symptoms until the contagion is over. Children **MUST** have a written note from their physician to be readmitted to school after having any of the following diseases:

**Hepatitis, Plantar's Warts, Ringworm of skin or scalp, Strep Throat or Infection, Mononucleosis, Rash of unknown origin, Scarlet Fever, Tuberculosis**

### **Schedule of Readmittance to School Following Communicable Disease Incident**

Measles - excluded for 5 days after appearance of rash

German Measles - excluded until rash has disappeared

Chicken Pox - 7 days after appearance of rash

Mumps - until all swelling of affected glands has disappeared

Whooping Cough - 14 days after whoop begins

Poliomyelitis - until febrile stage has passed

Meningococcal Meningitis - until febrile stage has passed

Streptococcal Sore Throat including Scarlet Fever - until febrile stage has passed

Infectious Hepatitis - until febrile stage has passed

After any of these illnesses, the child may return to school only after the exclusion period has passed with a note from a treatment agency.

Infectious Mononucleosis - This is not a "reportable disease" at present, and there is no legally set period of exclusion from school. It is recommended however, that the child remain at home until the febrile stage of the disease has passed.

Scabies, Impetigo, Acute Conjunctivitis (pinkeye), Ringworm of Face, Trunk or Extremities - The child may return to school as soon as signs of the infection are no longer present.

Ringworm of Scalp - The child may attend school with ringworm of the scalp provided he is under medical care. No special precautions or restrictions need be used.

Pediculosis or Head Lice - Students are checked the first day of school and the day they return from each school holiday. If lice or nits (eggs) are found, the parent will be called to pick up the child. After

treatment and all lice and nits are removed from the hair, student must go to doctor and receive permission to return to school.

### **Entering/Exiting the Facility**

Pre-K through 8<sup>th</sup> grade will enter on the Crescent Street side of the building. High School will enter on the 27<sup>th</sup> street side. Pre-k through 2<sup>nd</sup> grade will exit through the front door on Crescent Street. 3<sup>rd</sup> through 5<sup>th</sup> grade will exit through the North Gate on Crescent Street. Middle School will exit through the South Gate on Crescent Street. High School will exit through the 27<sup>th</sup> Street lobby.

### **Medication**

If your child needs to take prescription medicine during the school day, kindly send a note from your doctor to the school nurse and she will contact you. Department of Health has advised us not to supervise the administration of any medication. This is for our mutual protection.

### **Illness in School**

When a child has a fever of 100 degrees or more, has diarrhea or throws up in school, the parent will be called and the child must be picked up by the parent or an adult sent by the parent within an hour. The child will not be allowed to stay at school that day.

### **Returning to School after Absence**

When a student is absent 3 days or more for illness, the parent may be asked to bring a doctor's note, indicating that he/she can return to school.

### **Pupils Wearing Casts and/or Using Crutches**

Pupils wearing casts and/or using crutches should report to the school office before going to class. He or she may attend school if approval in writing by the family physician and parents indicate to the satisfaction of the principal that the wearing of said cast does not interfere with the child's normal school routine except for gymnasium or playground activities. The note from the family physician should state the diagnosis and extent of activity participation.

### **Elevator**

Students are not allowed to use the elevator without an elevator pass.

### **Lunch**

Each student may bring his own lunch that is eaten in the lunchroom. Students may order by the month a lunch provided by the City. Students that qualify may receive free or reduced lunch rates. Students may purchase lunch from the café.

High School students will be permitted to leave for lunch only if consent slip has been signed by parents at beginning of year.

**Snack Time** - Students in Pre-K through the Fifth Grade should bring a nutritious snack for the morning break.

Each day Elementary classes will have a 15 minute snack break. Please send healthy snacks for your child to eat and drink. If your child does not have a snack the school will provide one. You will receive a note or a call to let you know that your child did not have a snack. If your child continues to not have snack you will be notified and the school will bill you 25 cents for each snack provided

**Parties** – Arrangements for an in school birthday party must be made with the teacher in advance. Themes, decorations and party gifts should be consistent with School Philosophy. Designs depicting

violent characters, scenes or symbols of movie, video or cartoon characters that emphasize anti-social behavior and non-Christian principles should not be used. This includes decorations or themes involving movie, music or TV personalities who don't exhibit a Christian lifestyle.

**Lost Books** – A replacement of a lost textbook or workbook will be ordered and parents assessed the cost.

**Lost and Found** – Any article found in corridors, chapel, gym, cafeteria and play yards will be put in the lost and found bin in the gym area.

**Library** – Students in all grades are scheduled for a weekly library visit. Students in grades 1 through 8 are allowed to take out books. Books may be taken out for one week and brought back the following week to be renewed or returned. If a library book is lost or damaged, the fine is \$10 per book.

### **Regulations Regarding School Supplies**

Evangel Christian School is committed to Christian principles and values. This task is made more difficult by the media. Most of the TV, advertising, videos, movies and music has a negative impact on our children. To maintain a positive standard, we must ask that all parents cooperate with us by NOT SENDING TO SCHOOL -- supplies ( such as book bags, lunch boxes, knapsacks, folders, pencils, erasers, etc. ) which have pictures or designs depicting violent characters, scenes or symbols of movie, video or cartoon characters that emphasize anti-social behavior and non-Christian principles. This includes movie, music and TV personalities who don't exhibit a Christian lifestyle; for example, **Power Rangers, X-Men, Batman, Goosebumps, Harry Potter, WWE, Zodiac Symbols, Pokemon and similar characters, and secular entertainers, Twilight, etc.**

### **Visitors**

All visitors, parental, or otherwise, must obtain written permission from the school office before going to any part of the school. All interested students who wish to visit the school for a day, must request permission from the school principal. All visitors must report to the office and sign in with security. Students may not have visitors sit in on classes with them. Students who wish to have a friend visit school during chapel or lunch must have prior approval from the principal.

Parents and other visitors shall be in the building during the school day for one of the following reasons:

Previously scheduled conference; Previously P. T. F. arranged activities and assignments; Previously scheduled appointments for classroom visitation; Involvement in school activities by request of a teacher or the administration; Dropping something off in the office for your child.

### **CHANGES TO POLICIES**

The ECS Board reserves the right, in its sole discretion, to alter, amend, repeal, any policy, or to adopt new policies when, it determines it to be in the best interest of the School, following written notice to all Parents/Guardians by the appropriate administrator. Parents/Guardians agree to abide by the current policies and any changes or modifications made pursuant to this provision.
